- Fine Art Print of your artwork (printed in the size 30 x 40 cm by the PAKS Gallery and exhibited in the frame 40 x 50 cm) - ~~900 Euro~~ € 810
- Gallery representation with the wall 1m wide x 2,5 m high in the PAKS Gallery (maximal size of the artwork 100cm wide x 160cm high) + one artwork in the storage of the gallery during the representation time - ~~1900 Euro~~ € 1710
